



- By-law No. 78-69, a by-law to designate the Pohran Residence at 4891 Portage Road of architectural value and of historic interest, registered as Instrument No. 309564

To date the Municipal Council has designated ten buildings of historical or architectural significance within the municipality of Niagara Falls.

A By-law to designate the Pohran Residence at 4891 Portage Road of architectural value and of historic interest.

INTRODUCED BY

By-law No. 78 - 69

A by-law to designate the Pohran Residence at 4891 Portage Road of architectural value and of historic interest.

WHEREAS The Ontario Heritage Act, 1974, authorizes the Council of a municipality to enact by-laws to designate real property, including all the buildings and structures thereon, to be of historic or architectural value or interest;

AND WHEREAS the Council of The Corporation of the City of Niagara Falls has caused to be served upon the owner of the lands and premises municipally known as 4891 Portage Road, commonly known as the Pohran Residence, upon The Ontario Heritage Foundation, Notice of Intention to so designate the aforesaid real property and has caused such Notice of Intention to be published in a news paper having general circulation in the municipality once for each of 3 consecutive weeks;

AND WHEREAS the reasons for designation are set out in Schedule "B" hereto; AND WHEREAS no Notice of Objection to the proposed designation has been served upon the Clerk of the municipality.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NIAGARA FALLS ENACTS AS FOLLOWS:

1. That the real property more particularly described in Schedule "A" hereto, known as the Pohran Residence at 4891 Portage Road be designated as being of architectural value or interest.

2. The City Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper Land Registry Office.

3. The City Clerk is hereby authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon The Ontario Heritage Foundation and to cause notice of this by-law to be published in a news paper having general circulation in the City of Niagara Falls.

REASONS FOR DESIGNATION OF THE POHRAN RESIDENCE

The Pohran residence was originally built by John Thomson around 1825 and was at one time part of a very large farm. It is a stone structure with walls 3 feet thick and exhibits some marvellous ornamental detail in the dormers and entry porch. A small portion in the rear is said to date from around 1800 and supposedly was the site of the first meeting of the Masons in the area.
