By-law No. 78 - 66

A by-law to designate the Weaver Homestead at 6590 Dunn Street of architectural value and of historic interest.

WHEREAS The Ontario Heritage Act, 1974, authorizes the Council of a municipality to enact by-laws to designate real property, including all the buildings and structures thereon, to be of historic or architectural value or interest;

AND WHEREAS The Council of the Corporation of the City of Niagara Falls has caused to be served upon the owner of the lands and premises municipally known as 6590 Dunn Street, commonly known as the Weaver Homestead, upon The Ontario Heritage Foundation, Notice of Intention to so designate the aforesaid real property and has caused such Notice of Intention to be published in a news paper having general circulation in the municipality once for each of 3 consecutive weeks;

AND WHEREAS the reasons for designation are set out in Schedule "B" hereto;

AND WHEREAS no Notice of Objection to the proposed designation has been served upon the Clerk of the municipality.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NIAGARA FALLS ENACTS AS FOLLOWS:

- 1. That the real property more particularly described in Schedule "A" hereto, known as the Weaver Homestead at 6590 Dunn Street be designated as being of architectural value or interest.
- 2. The City Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper Land Registry Office.
- 3. The City Clerk is hereby authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon The Ontario Heritage Foundation and to cause notice of this by-law to be published in a news paper having general circulation in the City of Niagara Falls.

REASONS FOR DESIGNATION OF THE WEAVER HOMESTEAD

The old Weaver home built around 1835 by Henry Spence, an excellent mason in the area stands to-day in the midst of a modern subdivision. The house is built in two sections; the rear portion a wood frame settlers cabin built around 1800, and the front portion built of brick by Spencer. Built in the simple Georgian style common to Upper Canada at the time, it is still in excellent condition to-day. An old brick scullery containing the well preserved remains of a cauldron, bread oven, well and an engraved iron plate dated in 1827 adjoins the cabin portion of the home.
