NOTICE OF INTENTION TO REPEAL DESIGNATING BY-LAW NO. 2002-054

PURSUANT TO THE PROVISIONS OF THE ONTARIO HERITAGE ACT R.S.O. 1990, SECTION 32

TAKE NOTICE that the Council of the Corporation of the City of Niagara Falls intends to repeal the designating by-law on the 12th day of May, 2015, as detailed below

Rev. William Leeming House 5781 Highland Avenue

PURPOSE AND EFFECT OF THE REPEAL

Niagara Falls City Council made a decision to repeal By-law No. 2002-054. The purpose and effect of the repeal would remove the heritage designation. The by-law to repeal will be passed at a later date provided no appeal is filed.

EXPLANATION OF THE REPEAL

Council approved the request of the owner to repeal on May 12, 2015, on the basis that the building was structurally deteriorated to such a state that it is not financially viable to restore the building.

APPEAL TO THE CONSERVATION BOARD

Any member of the public may appeal the repeal of this by-law to the Conservation Review Board by filing a notice of appeal, setting out the reasons for the appeal, with the Clerk of the Corporation of the City of Niagara Falls, within 30 days of the receipt of this notice. Receipt of Notice is deemed to be 7 days from the date of mailing.

The last day for filing a notice of appeal is July 6, 2015.

The decision of the Council of the Corporation of the City of Niagara Falls is final if a notice of appeal is not received before or on the last day for filing a notice of appeal.
