THE CORPORATION OF THE TOWN OF AMHERSTBURG

BY-LAW NO. 1994

A by-law to repeal by-law No. 1421

WHEREAS by by-law No. 1421, passed June 28th, 1976, the Council of the Corporation of the Town of Amherstburg designated the lands described in Schedule "A" hereto and the Gordon House, then located thereon, as of historical and architectural significance, pursuant to S. 29 (14)(a) of the Ontario Heritage Act, R.S.O. 1980, after considering a report of the Review Board.

AND WHEREAS the owner of the lands on which the Gordon House was situated did on October 27th, 1980, and on January 7, 1981 apply to the council of the Corporation of the Town of Amherstburg, pursuant to S. 34(1) of the Ontario Heritage Act for consent in writing to the demolition or removal of the Gordon House.

AND WHEREAS the said Council refused the application, but the period of 180 days provided under S. 34(5)(b) of the Ontario Heritage Act has now expired, and the owner and the said council did agree to the preservation of the Gordon House by its physical removal by the Town of Amherstburg to another site.

AND WHEREAS the removal of the Gordon House has now been completed.

NOW THEREFOR THE COUNCIL OF THE CORPORATION OF THE TOWN OF AMHERSTBURG HEREBY ENACTS AS FOLLOWS:-

1. By-Law No. 1421, passed June 28th, 1976, designating the lands described in Schedule "A" hereto, and the buildings located thereon, to be of historical and architectural significance is hereby repealed, pursuant to S. 34(5) of the Ontario Heritage Act, R.S.O. 1980.
2. Copies of this by-law shall be served upon the owner of the said lands and upon the Ontario Heritage Foundation.
3. Notice of this by-law shall be published in the Amherstburg Echo, a newspaper having general circulation in the Town of Amherstburg.
4. Reference to the lands described in Schedule "A" hereto shall be deleted from the register of designated properties

kept by the clerk.

5. A copy of this by-law shall be registered against the property described in Schedule "A" hereto in the Land Registry Office for Essex (No. 12).
6. This by-law shall come into force and take effect on the date of its final passing.
