AND IN THE MATTER OF THE LANDS MUNICIPALLY KNOWN AS SECOR FAMILY BURIAL PLOT, LOCATED IN PART OF LOT 18, CONCESSION D, WEST SIDE OF STEVENWOOD ROAD IN THE CITY OF SCARBOROUGH IN THE PROVINCE OF ONTARIO

NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of The Corporation of the City of Scarborough has decided to designate the lands, known municipally as Secor Family Burial Plot, as a property of historical value or interest under The Ontario Heritage Act, 1974, S.O., Chapter 122.

SHORT STATEMENT OF THE REASONS FOR THE PROPOSED DESIGNATION:

SECOR FAMILY BURIAL PLOT is recommended for designation for historical reasons, being the final resting place for members of one of Scarborough's early pioneer family members, including Scarborough's first Reeve, Peter Secor. The designation included a large cairn erected in 1938 which contains those flat monuments uncovered at that time. These markers have been mounted into the vertical sides of the cairn with the inscriptions exposed.

Notice of objection to the designation may be served on the Clerk within thirty days of June 1, 1994.
