Re: Request to repeal Bylaw 2007-60 Being a Bylaw to designate the property at 1105 Front Rd S and known as the Patrick Laferte House under Part IV of the Ontario Heritage Act

Please be advised that a request by the property owner to repeal Bylaw 2007-60, being a Bylaw to Designate the property at 1105 Front Rd South, Amherstburg, was discussed at the Town of Amherstburg Regular Council Meeting of March 18, 2013. 
