|      | WHEREAS Section 29 of the Ontario Heritage Act, 1974 authorizes the<br>Council of a municipality to enact by-laws to designate real<br>property, including all buildings and structures thereon, to be of<br>architectural or historic value or interest; and   |
|      | WHEREAS the Council of the Corporation of the Township of Elizabethtown<br>has caused to be served on the owners of the lands and premises known<br>as The McLean House at Pt. Lot 23, Concession 1, RP Plan 28R-1473, Part<br>3, and upon the Ontario Heritage Foundation, notice of intention to so<br>designate the aforesaid real property and has caused such notice of<br>intention to be published in the same newspaper having general<br>circulation in the municipality once for each of three weeks; and |
| i.   | WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the Municipality;  |
|      | NOW THEREFORE the Council of the Corporation of the Township of<br>Elizabethtown enacts as follows:   |

|      | (2) The municipal solicitor is hereby authorized to cause<br>a copy of this by-law to be registered against the<br>property described in Paragraph (1) hereto in the<br>proper land registry office.  |
|      | (3) The Clerk is hereby authorized to cause a copy of<br>this by-law to be served on the owner of the<br>aforesaid property and on the Ontario Heritage<br>Foundation and to cause notice of the passing of<br>this by-law to be published in the same newspaper<br>having general circulation in the municipality once<br>for each of three (3); consecutive weeks.  |
