NOTICE OF INTENTION TO DESIGNATE
ONTARIO HERITAGE ACT
103 OLD KINGSTON ROAD

TAKE NOTICE that the Council of the Corporation of the Town of Ajax intends to designate the property, including lands and buildings at 103 Old Kingston Road as a property of architectural and/or historical value or interest under Part IV of The Ontario Heritage Act, R.S.O. 1990, Chapter O. 18.

Municipal Address: 103 Old Kingston Road, Part Lots 9 & 10, Plan 11, Town of Ajax, Region of Durham, Province of Ontario

Reason for Designation:

This structure, known locally as "Gordon House", is detached with five bays on the front elevation, a fieldstone foundation, and exterior walls of highly decorative red brick with buff accents. The pane arrangement is two-over-two, with two sashes and double-hung throughout. Interior features are the front vestibule, the main staircase, and the two-tone hardwood floors.

Any person may, within thirty days of the first publication of this notice, send by registered mail or deliver to the Clerk of the Town of Ajax notice of his or her objection to the proposed designation together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the Town of Ajax will refer the matter to the Conservation Review Board for a hearing.

THE LAST DAY FOR FILING OBJECTIONS IS November 14, 1997.
