
Notice To Designate Building

NOTICE OF INTENTION of the Corporation of the Town of Arnprior to designate the David A. Gillies Building, 35 Madawaska Street, in the Town of Arnprior of architectural value, under the provisions of the Ontario Heritage Act, 1974.

TAKE NOTICE that the Council of the Corporation of the Town of Arnprior intends to designate the David A. Gillies Building, 35 Madawaska Street, more particularly described as all and singular that certain parcel or tract of land and premises situate, lying and being in the Town of Arnprior, in the County of Renfrew, and being composed of the south west part of Lot 13, and the west part of Lot 11 on John Street, Registered Plan No. 7, under the Ontario Heritage Act, 1974.

The reason for the proposed designation is as follows;

This building is a fine example of Victorian Architecture, and is the only Public Building in Arnprior which can properly be considered a landmark, dominating the eastern entrance to the Town. It is in very good condition, and in constant vital use as a public library, museum and activities site. Such a designation will assist in preserving it for the future.

ANY PERSON MAY, within thirty (30) days after the date of this notice, send by Registered Mail or deliver to the Clerk of the Town of Arnprior, notice of his objection, setting out the reason for the objection and all relevant facts.

Where no notice of objection is served within the thirty (30) day period the Municipal Council of the Corporation of the Town of Arnprior may pass a by-law designating this property. In the event an objection is received the Municipal Council will arrange for the proper hearing of same.

THE LAST DATE FOR FILING OBJECTIONS WILL BE AUGUST 12TH, 1977.

DECISION that the Council of the Corporation of the Town of Arnprior wishes to designate the David A Gillies Building, 35 Madawaska Street, more particularly described as all and singular parcels of land or tract of land and premises situated, lying and being in the town of Arnprior, in the County of Renfrew, and being the south west part of Lot 13, and the west part of Lot 11 on the registration Plan No. 7, under the Ontario Heritage Act,

for the proposed designation is as follows:

It is a fine example of Victorian Architecture, and is the finest building in Arnprior which can properly be considered as contributing to the eastern entrance to the Town. It is in very good condition and in constant vital use as a public library, museum and office. Such a designation will assist in preserving it for the benefit of the Town.

ON MAY, within thirty (30) days after the date of this notice, a copy of this notice shall be sent by Registered Mail or deliver to the Clerk of the Town of Arnprior, or to the Clerk of his objection, setting out the reason for the objection and all relevant facts.

If a copy of objection is served within the thirty (30) day period, the Municipal Council of the Corporation of the Town of Arnprior may pass a by-law designating this property. In the event an objection is not received the Municipal Council will arrange for the proper
