
Take notice that the Council of the Corporation of the City of Toronto, on the 3rd day of March, 1976, decided to designate the lands and buildings, known municipally as 504 Jarvis Street, as a property of architectural value or interest under The Ontario Heritage Act, 1974, 1974 S.O. Chapter 122.

Short Statement of the Reasons for the Proposed Designation:

The G.H. Gooderham House at 504 Jarvis Street, built c. 1891 by David Roberts, is recommended for designation for architectural reasons as a fine example of the Romanesque Revival style as it developed in Toronto. The house is also the work of a Toronto architect of note. It is important in terms of the local streetscape as the southernmost unit of a series of houses between Cawthra Square and Gloucester Street that form the best preserved and perhaps most typical section of the nineteenth century Jarvis Street streetscape.

Notice of objection to the designation may be served on the Clerk within thirty days of the 24th day of March, 1976. (Reference File 1136).
