BY-LAW NO. 04-062

BY-LAW TO DESIGNATE THE VOELKER HOUSE, IN THE CITY OF WATERLOO TO BE OF CULTURAL HERITAGE VALUE OR INTEREST.

WHEREAS Section 29 of the *Ontario Heritage Act, R.S.O. 1990*, c. O.19, as amended, (the "Act") authorizes the council of a municipality to designate property within the municipality to be of cultural heritage value or interest;

AND WHEREAS Council for The Corporation of the City of Waterloo deems it desirable to designate the Voelker House, located at 29 Spring Street West, Waterloo and built in 1947, to be of cultural heritage value or interest;

. AND WHEREAS the Clerk of the City of Waterloo has caused Notice of Intention to Designate to be given in accordance with Section 29(3) of the Act;

AND WHEREAS no Notice of Objection has been served on the Clerk within the meaning of Section 29(5) of the Act.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF WATERLOO ENACTS AS FOLLOWS:

- The property described as Part Lot 20 w/s Snider St Plan 491, City of Waterloo, as in 137398; Waterloo (PIN 22375-0004 LT) (the "Designated Property") is hereby designated to be of cultural heritage value or interest.
- 2. Section 33 of the Ontario Heritage Act, R.S.O. 1990, c. 0.19, as amended, shall apply only to all facades of the house on the Designated Property.
- This By-law shall come into effect on the final passing thereof by the Council of The Corporation of the Čity of Waterloo.
