
I am enclosing herewith a notice of intention to designate the above mentioned property to be of historic and architectural value within the meaning of the Ontario Heritage Act.

NOTICE OF INTENTION TO DESIGNATE

NOTICE is hereby given that the Council of the Corporation of the City of Kitchener intends to designate the hereinafter mentioned property to be of historic and architectural value within the meaning of Section 29 of the Ontario Heritage Act, 1974.

THE subject property is located on lots 26, 27, 28 small lots north of Peter Horning's Tract, Bloomingdale Road and is owned by the City of Kitchener. It is intended that the Free Church and the graveyards and lands located within the boundary of the subject property will be designated.

THE Free Church, built in 1848, is reportedly the second oldest church in the Regional Municipality of Waterloo. There are few structures of early brick construction (1840-1850) that exist which possess the Georgian design exhibited by the Free Church. Furthermore, the Free Church is not only significant for its method of construction, but also for its unique historical background.

NOTICE of Objection to this designation may be served on the Clerk of the City of Kitchener within thirty days of this Notice. Any Notice of Objection shall indicate the reasons for the Objection and all relevant facts.
