BY-LAW NO. 07-111

BY-LAW TO DESIGNATE THE EBY-SNIDER HOUSE, IN THE CITY OF WATERLOO TO BE OF CULTURAL HERITAGE VALUE OR INTEREST.

WHEREAS Section 29 of the *Ontario Heritage Act, R.S.O. 1990, c. O.18*, as amended, (the "Act") authorizes the council of a municipality to designate property within the municipality to be of cultural heritage value or interest;

AND WHEREAS Council for The Corporation of the City of Waterloo deems it desirable to designate the Eby-Snider House, located at 78 Erb Street East, Waterloo to be of cultural heritage value or interest;

AND WHEREAS the Clerk of the City of Waterloo has caused Notice of Intention to Designate to be given in accordance with Section 29(3) of the Act;

AND WHEREAS no Notice of Objection has been served on the Clerk within the meaning of Section 29(5) of the Act.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF WATERLOO ENACTS AS FOLLOWS:

1. The property described as Lots 1- 2 Plan 512 City of Waterloo Except Part 5, 58EX312; Waterloo (PIN 22373-0032 (LT)) (the "Designated Property") is hereby designated to be of cultural heritage value or interest.
2. Section 33 of the *Ontario Heritage Act, R.S.O. 1990, c. O.18*, as amended, shall apply only to all facades of the house on the Designated Property.
3. This By-law shall come into effect on the final passing thereof by the Council of The Corporation of the City of Waterloo.
