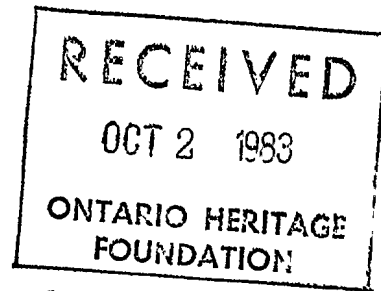

NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the City of Kitchener intends to designate the property at the following municipal address as a property of historic and architectural value under Part IV of The Ontario Heritage Act, R.S.O. 1980, Chapter 337.

The subject property is located at 137 Queen Street South. It is intended that in particular, the spire, the complete exterior north wall, and the portion of the south wall comprising of the ornate brickwork over the windows and under the eaves of St. Paul's Evangelical Lutheran Church be designated.

The designation described herein is recommended on historic and architectural grounds. The Church was constructed in 1889 and is one of the oldest churches in Kitchener. In terms of architecture, the Church exhibits the Gothic style and possesses several significant details including the spire, pointed arches in all of the bay openings, stained glass windows which are of the long, narrow, Lancelot form, and detailed brickwork over the arch windows and under the eaves.

Any person may, within thirty days of the first publication of this notice, send by registered mail or deliver to the Clerk of the City of Kitchener notice of his or her objection to the proposed designation together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the City of Kitchener shall refer the matter to the Conservation Review Board for a hearing.
