NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the City of Kitchener intends to designate the property at the following municipal address as a property of architectural value under Part IV of The Ontario Heritage Act, R.S.O. 1980, Chapter 337.

The subject property is located at 26 Durham Street and is owned by [REDACTED]. It is intended that in particular, the stone side facades, the stone projecting central and recessed street facades, the sharply pitched gables, the six over six paned windows of the stone structure, the wooden shutters around the windows, the recessed front door having transom and sidelights with chinoiserie of glass and the porch with wooden posts, railing and dogtooth ornament under the eaves, be designated.

The designation described herein is recommended on architectural grounds. This 1858 house is a fine example of the Picturesque style.

Any person may, within thirty days of the first publication of this notice, send by registered mail or deliver to the Clerk of the City of Kitchener notice of his or her objection to the proposed designation together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the City of Kitchener shall refer the matter to the Conservation Review Board for a hearing.
