COMMITTEE OF ADJUSTMENT

BY-LAW NUMBER 87-312

OF THE

CORPORATION OF THE CITY OF KITCHENER

(Being a by-law to designate part of the property known as German Evangelical Lutheran Church Cemetery - Strasburg Road in the City of Kitchener as being of historic and architectural value)

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1980, Chapter 337, authorizes the Council of a Municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historical value or interest;

AND WHEREAS the Council of The Corporation of the City of Kitchener has caused to be served on the owner of the lands and premises known as German Evangelical Lutheran Church Cemetery - Strasburg Road in the City of Kitchener, and upon the Ontario Heritage Foundation, a Notice of Intention to Designate as being of historical and architectural value that part of the aforesaid real property more particularly hereinafter described, and has caused such Notice of Intention to be published in a newspaper having general circulation in the municipality once for each of three consecutive weeks;


AND WHEREAS no Notice of Objection to the proposed designation has been served upon the Clerk of the Municipality;

NOW THEREFORE the Council of The Corporation of the City of Kitchener enacts as follows:

1. There is designated as being of historical and architectural value that part of the aforesaid real property known as the German Evangelical Lutheran Church Cemetery - Strasburg Road being comprised of the east side of Strasburg Road approximately 1/3 mile south of the Bleams Road intersection.
2. The City Solicitor is hereby authorized to cause a copy of this By-law to be registered against the whole of the property described in Schedule "A" hereto (of which the said designated area forms a part) in the proper land registry office.

3. The Clerk is hereby authorized to cause a copy of this By-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this By-law to be published in the same newspaper having general circulation in the community once for each of three consecutive weeks.

SCHEDULE "A"

Part of Bechtel's Tract, Part of Lot 3, Registrar's Compiled Plan 1478 and Part of Lot 14, Registrar's Compiled Plan 1471 designated as Parts 24, 25 and 31 on Plan 58K-5010 for the City of Kitchener in the Regional Municipality of Waterloo

Part of the above described land includes part of Strasburg Road but was never dealt with by a by-law.

REASONS FOR DESIGNATION

The designation described herein has been made on historic and architectural grounds. The cemetery was started in 1850 and is an example of an early pioneer cemetery, with tablet style and small stone markers of marble, limestone and sandstone.
