Take notice that Council for the Corporation of the City of Windsor on the 26th day of July, 1976, decided to designate the lands and buildings known municipally as 3203 Peter Street, as a property of architectural and historic value or interest under the Ontario Heritage Act, 1974, 1974 S.O. Chapter 122.

The reason for the proposed designation is that the Girardot House, 3203 Peter Street, is a fine example of Victorian Architecture, with many remaining early 20th Century interior and exterior architectural features including an iron fence along Peter and Mill Streets.

The first of three advertisements of the "Notice of Intention to Designate" (copy attached) was published in the Windsor Star, Friday, August 13, 1976.
