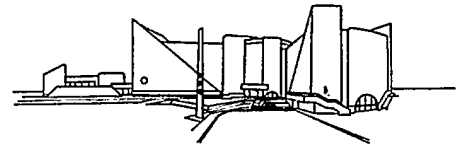

THE CORPORATION OF THE
BOROUGH OF SCARBOROUGH

BY-LAW NUMBER 19686

to designate the Birchmount Firehall under The
Ontario Heritage Act as being of historical
and architectural value

WHEREAS The Ontario Heritage Act, 1974, S.O.
Chapter 122, authorized the Council of a municipality to enact
by-laws to designate a real property, including all the buildings
and structures thereon, to be of historic or architectural value
or interest; and

WHEREAS the Council of The Corporation of the
Borough of Scarborough has caused to be served upon the owners
of the lands and premises known as the Birchmount Firehall on
the south east corner of Birchmount Road and Highview Avenue
and upon the Ontario Heritage Foundation notice of intention to
so designate the aforesaid real property and has caused such
notice of intention to be published in a newspaper having a
general circulation in the municipality once for each of three
consecutive weeks; and

WHEREAS the reasons for designation are set out in
Schedule "B" hereto; and

WHEREAS no notice of objection to the said proposed
designation has been served upon the Clerk of the municipality;

THEREFORE, THE COUNCIL OF THE CORPORATION OF THE
BOROUGH OF SCARBOROUGH ENACTS AS FOLLOWS:

1. There is designated as being of architectural value
or interest the real property more particularly described in
Schedule "A" hereto, known as the Birchmount Firehall on the
south east corner of Birchmount Road and Highview Avenue.
2. The Borough Solicitor is hereby authorized to cause
a copy of this by-law to be registered against the property
described in Schedule "A" hereto in the proper land registry office.
3. The Borough Clerk is hereby authorized to cause a

copy of this by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in a newspaper having general circulation in the Borough of Scarborough.

BY-LAW NUMBER 19686

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Borough of Scarborough in the Municipality of Metropolitan Toronto and being composed of the whole of Lots 504, 505 and 506 according to a Plan registered in the Registry Office for the Registry Division of Toronto Boroughs (No. 64) as Number 1964.

The Birchmount Firehall

This structure is recommended for historical reasons. Under the direction of Fire and Police Chief, W. F. Scott, the 1925 building not only housed the Township's first fire department but the police department as well. It was also used as the Township jail for a number of years. The hose tower is unique in the Borough and although common in downtown Toronto, it provides modern day residents with a true historical picture of a fire-hall in what was once a rural settlement.
