
re: Repeal of By-law No. 21183 -

Recommendation embodied in Report No. 36 of the BOARD OF CONTROL adopted by Council at its meeting held on October 19, 1987

### 1. Mammoth Hall - Designation under The Ontario Heritage Act

Board of Control received the following report (October 8, 1987) of the City Clerk, viz:

#### "REPORT:

The above building, which was a designated site under The Ontario Heritage Act, has now been destroyed by fire. As required by The Ontario Heritage Act, the Local Architectural Conservation Advisory Committee has been requested to comment on the repeal of the by-law designating this site. In a letter dated September 30, 1987, they recommended repeal of the designating by-law.

#### RECOMMENDATION:

That the by-law designating Mammoth Hall a historic site under The Ontario Heritage Act be repealed and that the Clerk be authorized to take whatever action necessary to comply with The Ontario Heritage Act in this regard."

BOARD OF CONTROL RECOMMENDS adoption of the foregoing report of the City Clerk.
