Re: Heritage Designation of Dunke House
2 William Street, Elmira, Ontario

Correspondence was circulated from the Township of Woolwich Local Architectural Conservation Advisory Committee requesting Council to designate the above noted property.

At session of Council held February 14, 1984, the following resolution was adopted:

"THAT the Heritage Designation of the Dunke House located at 2 William Street, Elmira, be referred to the Township Solicitor for processing."

Chapter 122 of The Ontario Heritage Act, Section 29(3), indicates that a Notice of Intention to Designate shall be served on the owner of the property and on The Heritage Foundation, and also published in a newspaper having general circulation in the municipality. Enclosed is a public notice of Intention to Designate which provides an adequate description of the property, a statement for the reason for the proposed designation, and a statement that Notice of Objection to the designation may be served on the Clerk within 30 days of the date of the first publication of the Notice of Intention, in a newspaper having general circulation in the municipality. The Notice of Intention to designate will be published in the Kitchener-Waterloo Record once each week for three consecutive weeks on the following dates: Saturday, May 19, 1984, Saturday, May 26, 1984, and Saturday, June 2, 1984.

PUBLIC NOTICE

NOTICE is hereby given that the Council of The Corporation of the Township of Woolwich intends to designate the hereinafter-mentioned property to be of historic and architectural value within the meaning of Section 29 of The Ontario Heritage Act, R.S.O. 1980.

THE SUBJECT property is known as the Dunke House and is located on lands municipally known as 2 William Street, Elmira, in the Township of Woolwich, and is composed of the whole of Lot 21 according to Registered Plan 571, Township of Woolwich, Regional Municipality of Waterloo.

THE DUNKE HOUSE was constructed in 1891 by Jacob Dunke. Architecturally, the House incorporates features of the Queen Anne Revival Style and is a well-preserved example of Victorian architecture. The House is also of historic significance inasmuch as it served as a residence for certain prominent members of the community, namely, Jacob Dunke, Armand C. Kimmel and Oscar H. Vogt.

NOTICE OF OBJECTION to this designation may be served on the Clerk within Thirty (30) days of the date of this Notice. Any notice of objection shall indicate the reasons for the objection and all relevant facts.


