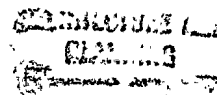



TOWNSHIP OF WOOLWICH

BY-LAW NUMBER 74-94

A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS 38 KING STREET, ST. JACOBS, IN THE TOWNSHIP OF WOOLWICH AS BEING OF ARCHITECTURAL OR HISTORICAL VALUE OR INTEREST

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1990, Chapter 0.18, as amended, authorizes the Council of a municipality to designate property within the municipality to be of architectural or historical value or interest;

AND WHEREAS the Council of the Corporation of the Township of Woolwich deems it desirable to designate 38 King Street, St. Jacobs, in the Township of Woolwich, to be of architectural or historical value or interest;


AND WHEREAS the Clerk of the Township of Woolwich has caused Notice of Intention to Designate to be given in accordance with Section 29(3) of the Ontario Heritage Act, R.S.O., 1990, Chapter 0.18, as amended;

AND WHEREAS no Notice of Objection has been served on the Clerk within the meaning of Section 29(5) of the Ontario Heritage Act, R.S.O. 1990, Chapter 0.18, as amended;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF WOOLWICH ENACTS AS FOLLOWS:

1. The property described in Schedule "A" attached hereto is hereby designated to be of architectural or historical value or interest. The reasons for designation are set out in Schedule "B" attached hereto.
2. This by-law shall come into effect on the final passing thereof by the Council of the Corporation of the Township of Woolwich.
