THE CORPORATION OF THE TOWNSHIP OF WOOLWICH

BY-LAW NO. 46-80

BY-LAW TO DESIGNATE THE CONESTOGO UNITED CHURCH IN THE TOWNSHIP OF WOOLWICH TO BE OF HISTORIC AND ARCHITECTURAL VALUE OR INTEREST.

WHEREAS Section 29 of The Ontario Heritage Act, 1974 authorizes Council of a municipality to designate property within the municipality to be of historic value or interest;

AND WHEREAS Council for The Corporation of the Township of Woolwich deems it desirable to designate The Conestogo United Church to be of historic and architectural value or interest insofar as the Conestogo United Church, constructed in 1878 was the first Methodist church in the immediate area;

AND WHEREAS architecturally, the Conestogo United Church is of the "Vernacular Style" and its original form has been relatively unaltered with subsequent additions or repairs;

AND WHEREAS the building is in a good state of preservation and its simplicity adds to its charm and is representative of the workmanship of that era;

AND WHEREAS the Clerk of the Township of Woolwich has caused Notice of Intention to Designate to be given in accordance with Section 29(3) of The Ontario Heritage Act, 1974;

AND WHEREAS no Notice of Objection has been served on the Clerk within the meaning of Section 29(5) of The Ontario Heritage Act, 1974.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF WOOLWICH ENACTS AS FOLLOWS:

1. The Conestogo United Church located on lands described

in Schedule "A" attached hereto is hereby designated to be of historic and architectural value or interest.

2. This By-law shall come into effect on the final passing thereof by the Council of The Corporation of the Township of Woolwich.

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Township of Woolwich, in the Regional Municipality of Waterloo (formerly in the Village of Conestogo) and in the Province of Ontario and being composed of Lot 11, North of King Street, East of Water Street, Registered Plan 601, David Musselman's Survey for the said Township of Woolwich (formerly Village of Conestogo).
