THE CORPORATION OF THE TOWN OF KINCARDINE

BY-LAW NO. 4144 - 1978

BEING A BY-LAW TO DESIGNATE THE VICTORIA PARK (DURHAM MARKET SQUARE) OF ARCHITECTURAL VALUE.

WHEREAS the Ontario Heritage Act, 1974 authorizes the Council of a municipality to enact by-laws to designate real property, including all the buildings and structures thereon, to be in historic or architectural value or interest; and

WHEREAS the Council of The Corporation of the Town of Kincardine has caused to be served upon the owner of the lands and premises known as Victoria Park (Durham Market Square) and upon the Ontario Heritage Foundation notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in a newspaper having a general circulation in the municipality once for each of three consecutive weeks; and

WHEREAS the reasons for designation are set out in Schedule "B" hereto, and

WHEREAS no notice of objection to the said proposed designation has been served upon the clerk of the municipality;

THEREFORE, The Council of the Corporation of the Town of Kincardine enacts as follows:

1. There is designated as being of architectural value or interest the real property more particularly described in Schedule "A" hereto, known as the Victoria Park (Durham Market Square).
2. The Town Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper land registry office.
3. The Town Clerk is hereby authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this By-law to be published in a newspaper having general circulation in the Town of Kincardine.

READ a FIRST and SECOND time this 20th day of April, 1978.



SCHEDULE "A"

BY-LAW 4144

ALL and SINGULAR that certain parcel or tract of land and premises, situate, lying and being in the Town of Kincardine in the County of Bruce, in the Province of Ontario and being composed of part of Durham Market Square as shown on the Town Plot of Penetangore, and designated as Parts 2 and 3 on a Plan deposited in the Land Registry Office for the Registry Division of Bruce (No.3) as Plan 3R-2164.
