



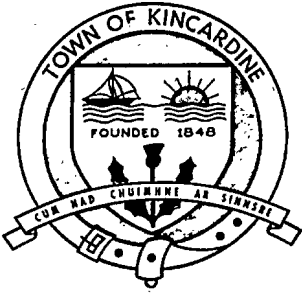



BY-LAW

BY-LAW NO. 1992-73.

BEING A BY-LAW TO DESIGNATE THE KNOX PRESBYTERIAN CHURCH, 345 DURHAM STREET, KINCARDINE, ONTARIO AS BEING OF HISTORIC OR ARCHITECTURAL VALUE

WHEREAS the Ontario Heritage Act, 1990, C.O. 18 authorizes the council of a municipality to enact by-laws to designate real property including all the building and structures thereon, to be of historic or architectural value and interest; and,

WHEREAS the Council of The Corporation of the Town of Kincardine has caused to be served on the owner of the lands and premises known as the Knox Presbyterian Church, 345 Durham Street, Kincardine, Ontario and upon The Ontario Heritage Foundation notices of intention to so designate the aforesaid property and has caused such notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in a newspaper having general circulation in the municipality once for each to three consecutive weeks; and,

WHEREAS the reasons for designation are set out in Schedule "B" hereto; and,

THEREFORE, the Council of The Corporation of the Town of Kincardine ENACTS as follows:

1. There is designated as being of architectural value and interest and real property more particularly described in Schedule "A" hereto, known as the Knox Presbyterian Church, 345 Durham Street, Kincardine, Ontario.
2. The clerk is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper land registry office.
3. The clerk is hereby authorized to cause a copy of the by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in a newspaper having general circulation in the Town of Kincardine.


4. This by-law may be cited as the "Knox Presbyterian Church Designation By-law".

SCHEDULE "A"

SCHEDULE FOR DESCRIPTION

Part of Lots 10, 11 and 12 on North Side of Durham Street, Town of Kincardine, County of Bruce.

Commencing at the Southwest Angle of Lot 12. Thence East along the ~~South limit of said Lot 12~~ a distance of 88 feet. Then North and parallel to West limit of said Lot 12 to a point in the North limit of Lot 12.

Thence West along the North limit of Lots 12, 11 and 10 a distance of 253 feet to a point in the North limit of said Lot 10, said point being 33 feet West of Northeast Angle of Lot 10.

Thence South and parallel to East limit of Lot 10 a distance of 120 feet.

Thence East and parallel to North limit of Lots 10 and 11 a distance of 165 feet to a point in West limit of Lot 12.

Thence South along the West limit of Lot 12 to the point of commencement.

SCHEDULE "B"

SCHEDULE FOR REASONS

PROPERTY: Knox Presbyterian Church, 345 Durham Street, Kincardine.

REASONS: This church was built in 1876 by David and Robert Donald, and continues to be a historical and architectural landmark. It is constructed of yellow brick, made locally. It is of gothic revival style with an impressive tower. The design of the windows and doors are gothic and each large window is of stained designed glass. Each window is protected on the outside by a framed clear glass window. The tower contains one of two church bells in existence in Kincardine (the other bell is now silent).


The total exterior, as described, includes windows, doors and bell.

The interior is of oak hardwood, plaster, glass and metal organ pipes.

The interior of the church is also of historical and architectural significance. The decorative printing on the walls and ceiling was done by Scott Young of Kitchener. Design of "TROMPE L'OEIL". The Sanctuary is of beautifully detailed carved wood.

The building is a copy of European churches built in the 10th - 12th centuries - thus the pointed arch windows, high vaulted roof, spire tower and flying buttresses.
