

BEING A BY-LAW TO DESIGNATE THE HOME OF [REDACTED] AT 1558 CONCESSION 12, MUNICIPALITY OF KINCARDINE (FORMER TOWNSHIP OF BRUCE) AS BEING OF HISTORIC OR ARCHITECTURAL VALUE

WHEREAS Section 29 (1) of the Ontario Heritage Act, R.S.O. 1990, c. O.18, as amended, authorizes the Council of a municipality to enact by-laws to designate a property within the municipality to be of cultural heritage value or interest;

AND WHEREAS the Council of the Municipality of Kincardine has caused to be served on the owner of the lands and premises known as the home of [REDACTED], 1558 Concession 12, Municipality of Kincardine and upon The Ontario Heritage Foundation, notice of intention to so designate the aforesaid property and has caused such notice of intention to so designate the aforesaid real property to be published in a newspaper having general circulation in the Municipality;

AND WHEREAS the reasons for designation are set out in Schedule "B" attached hereto;

NOW THEREFORE the Council of The Corporation of the Municipality of Kincardine ENACTS as follows:

1. There is designated as being of architectural value and interest the real property more particularly described in Schedule "A" hereto, known as the home of [REDACTED] 1558 Concession 12, Municipality of Kincardine, Ontario.
2. The Clerk is hereby authorized to cause of copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper land registry office.
3. The Clerk is hereby authorized to cause a copy of the by-law to be served upon the owner of the aforesaid property and upon The Ontario Heritage Foundation and to cause notice of this by-law to be published in a newspaper having general circulation in the Municipality of Kincardine.
4. This by-law shall come into full force and effect upon its final passing.
5. This by-law may be cited as the "1558 Concession 12 Heritage Designation By-law".





Heritage Designation – 1558 Concession 12
By-law No. 2008 – 174

Schedule "A"

The property is described as "Part 1, Part Lot H, Concession 13, RP3R 6937,
Roll # 41 08 260 003 16300 0000.

The said lands have a site area of 10.1 acres.

Schedule "B"

Designation shall cover three sides of the original stone building, being the front of the south facade, and the east and west facades. The home was built in 1885 by Alexander Brunton, a Scottish stonemason, who built several other structures in the Municipality and area.

Structure is a typical "Georgian" centre hall three bay plan of one and a half storeys with a central peak over the front door. Stone work is half rough cut with dressed limestone quoins, window and door frames. There are not many stone homes in the Municipality; three are known to have been built by Brunton.
