## THE CORPORATION OF THE TOWNSHIP OF COLLINGWOOD

BY - LAW NO. 84 - 4

A BY-LAW TO DESIGNATE THE PROPERTY KNOWN AS THE RAVENNA FORGE AS A BUILDING OF ARCHITECTURAL AND HISTORICAL INTEREST.

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1980, authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings or structures thereon, to be of architectural or historic value or interest;

AND WHEREAS the Notice of Intention to so designate the aforesaid Ravenna Forge has been duly given and also published in the local newspapers having general circulation, within the municipality once for each of three consecutive weeks and to the Ontario Heritage Foundation;

AND WHEREAS Council is of the opinion that the said Ravenna Forge is of historical and architectural interest having been operated as a blacksmith shop by Thomas Rusk for many years and subsequently by his son Angus. The building had been used continuously as a blacksmith shop until the 1940's and thereafter as a wrought iron forge until the mid 1970's;

AND WHEREAS it is a building typical of those built before the turn of the century and should be maintained and preserved for future generations to see and observe;

AND WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the Township;

NOW THEREFORE the Council of the Corporation of the Township of Collingwood enacts as follows:

- 1. That there is designated as being of architectural and historical interest the real property and buildings known as the Ravenna Forge in the Township of Collingwood more particularly described in Schedule 'A' hereto
- 2. That a copy of this By-law be registered against the property described in Schedule 'A' hereto in the Land Registry Office for the Land Registry Division of Grey North (No.16).
- 3. That a copy of this By-law be served on the Ontario Heritage Foundation and that notice of the passing of this By-law be published in the Beaver Valley Review Herald and the Valley Courier each for three consecutive weeks.
