The above is a synopsis of Bylaw No. 8497 passed by the Council of the Corporation of the City of Kingston on the 28th day of July, 1975, Bylaw No. 8654, passed on the 10th day of November, 1975, Bylaw No. 8892, passed on the 16th day of August, 1976 and Bylaw No. 8913, pass on the 13th day of September, 1976. All persons are hereby required to take notice that anyone desirous of applying to have such bylaw, or any part thereof, quashed must make his application for that purpose to the Supreme Court, within three months next after the first publication of this notice in the newspaper called the "Whig-Standard", or he will be too late to be heard in that behalf.

Copies of the foregoing bylaws setting forth the reasons for the designation may be obtained at the office of the Clerk - Comptroller. The bylaws referred to above have been sent to every registered owner affected by these bylaws and the bylaws have been registered on title.

Section 32 of The Ontario Heritage Act, 1974, states that the owner of a designated property may request municipal council to revoke the designation of his property. Where the council refuses the application of the owner he may, within 30 days, apply to the council for a hearing before the Conservation Review Board.

BY-LAW NO. 80-37

A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS 253 ONTARIO STREET, DESCRIBED AS PART 1, REFERENCE PLAN 13R-3627, AS BEING OF HISTORICAL AND ARCHITECTURAL INTEREST AND VALUE UNDER THE PROVISIONS OF THE ONTARIO HERITAGE ACT AND TO REPEAL BY-LAW NO. 79-101.

PASSED: February 11, 1980

WHEREAS Section 29 of The Ontario Heritage Act, 1974

authorizes the Council of a municipality to enact by-laws to

designate real property, including all buildings and structures

thereon, to be of architectural or historic value or interest;

AND WHEREAS the Council of The Corporation of the City of Kingston has caused to be served on the owners of the lands and premises known as 253 Ontario Street and upon The Ontario Heritage Foundation notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the Whig-Standard on January 26, 1979, February 2, 1979 and February 9, 1979;

AND WHEREAS the Conservation Review Board has held a hearing to determine whether the property in question should be
designated and reported its findings of fact and recommendations
to the Council;

AND WHEREAS the Conservation Review Board recommended that the property known municipally as 253 Ontario Street be designated as being of architectural and historical value and interest;

AND WHEREAS Council has considered the report of the Conservation Review Board;

THEREFORE the Council of The Corporation of the City of Kingston enacts as follows:

1. There is designated as being of architectural and historical value and interest the real property known municipally as

253 Ontario Street, more particularly described in Schedule "A" attached hereto.

- 2. The City Solicitor is hereby authorized to cause a copy of this by-law and the reasons for designation to be registered against the property described in Schedule "A" hereto in the Land Registry Office at Kingston, Ontario.
- 3. The City Clerk is hereby authorized to cause a copy of this by-law to be served by registered mail on the owners of the property described in Schedule "A" hereto and on The Ontaric Heritage Foundation, and to cause notice of the passing of this by-law to be published in the Whig-Standard once for each of three consecutive weeks.
- 4. By-Law No. 79-101 of The Corporation of the City of Kingston entitled "A By-Law to Designate the Property Known Municipally as 253 Ontario Street as being of Architectural or Historical Value or Interest" is hereby repealed.
- 5. This by-law shall come into force and take effect on its passing.



SCHEDULE "A" TO BY-LAW NO. 80-37

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the Province of Ontario, and in the City of Kingston, containing an area of 111 square meters more or less, and comprising that portion of the lands lying between Ontario Street and Water Lot 5 in the Original Survey of the Town of Kingston, designated as Part 1 on a plan of survey made by David T. Humphries, Ontario Land Surveyor, dated April 12, 1979, and deposited in the Land Registry Division of Frontenac (No. 13) on the 19th day of April, 1979 as Reference Plan No. 13R-3627.



REASONS FOR DESIGNATION OF 253 ONTARIO STREET, APPROVED AT THE MEETING OF CITY COUNCIL HELD ON FEBRUARY 4, 1980 (Clause 5, Report No. 16), AS PROPERTY OF HISTORIC AND ARCHITECTURAL SIGNIFICANCE

This stone building with parapeted end walls rising to massive chimneys, corner quoins and well proportioned additions occupies an important corner site. Built in the early 1820's for John Macaulay when he was postmaster and cashier of the Bank of Upper Canada, it was later occupied first by government, then for twenty years by Capt. John Gaskin.
