By-law No. L.S.P.- 2848-346

A by-law to designate 23 Peter  
Street of architectural value.

WHEREAS pursuant to The Ontario Heritage Act, R.S.O. 1980,  
c. 337 the Council of a municipality may by by-law designate a property  
including buildings and structures thereon to be of historic or architectural  
value or interest;

AND WHEREAS notice of intention to so designate the property  
at 23 Peter Street having been duly published and served, no notice  
of objection was received to such designation;

BE IT THEREFORE ENACTED by the Municipal Council of The Corporation  
of the City of London, as follows:

1. There is designated as being of architectural value or interest  
the real property, more particularly described in Schedule "A" hereto,  
at 23 Peter Street East, for the reasons set out in Schedule "B" hereto.
2. The City Clerk is authorized to cause a copy of this by-law  
to be registered upon the title to the property described in Schedule  
"A" hereto in the proper Land Registry Office.
3. The City Clerk is authorized to cause a copy of this by-law  
to be served upon the owner of the aforesaid property and upon the Ontario  
Heritage Foundation and to cause notice of this by-law to be published  
in the London Free Press, and to enter the description of the aforesaid  
property, the name and address of its registered owner, and short reasons  
for its designation in the Register of all properties designated under  
The Ontario Heritage Act, R.S.O. 1980.
4. This by-law comes into force on the day it is passed.

Architectural Reasons

Built c. 1877, 23 Peter Street is an exceptionally fine example of an Italianate town house. Two-and-one-half storeys in height and symmetrically balanced in composition, this white brick dwelling possesses many of the features typical of its architectural style. These include wide overhanging eaves, paired eaves brackets and a low-pitched hip roof, the attic in this instance lighted by a fanciful gable dormer. The balanced arrangement of the windows of the front elevation features segmental structural openings, highlighted by radiating voussoirs with vermiculated keystone. The multi-panelled door with its transom and sidelights provides the principal focus of the street facade.

The wood trim and plaster work of the interior are particularly fine. A large archway separates the present-day dining room and the parlour with their two handsome marble fireplaces.
