Historical Reasons

The first general store at the said location was built in 1876. It burnt down and was replaced by the present day structure in 1893 and again operated by Hunter and Hannah McRae. The store served as a community meeting place, post office, and general goods store. In 1983 the store was purchased by Margaret Wendy Pritchard who operates the Country Gift Store and Tearoom (main floor of the house).

Architectural Reasons

McRaes Country Store is noted for its boom town front on the store section to the west of the house. Its corbelling has chipped and the original wooden Victorian peak with side pillars has disappeared. The porch on the house and store had a balustrade with squared balusters. Their flat roofs have a mansard influence which were once covered with wood shingle in an imbricated pattern.

The lower railing and spindles of the house porch were replaced to copy the original remaining one in 1986. Two hand railings were then added. The store porch had a wide section of steps running half the width of the front porch. This was replaced in 1983 with a railing over plain spindles with a central flight of steps.

Victorian barge board exists around the eaves line of the yellow brick house which also features a slate roof. Rolled roofing exists over the main store while a metal roof is over the lower side store.

Galvanized metal evestroughing and down spouts encompass the roof lines. The property has two back porches off the rear of the store and house.

The inside of the main store boasts an original tin ceiling with elaborate corner pieces.

Several original windows exist in the premise. The most noteworthy are four original stained glass windows. All windows are encompassed by wooden sashes.
