By-law No. L.S.P.-3081-231

A by-law to designate 302 Central Avenue to be of architectural value.

WHEREAS pursuant to <u>The Ontario Heritage Act</u>, R.S.O. 1980, c. 337, the Council of a municipality may by by-law designate a property including buildings and structures thereon to be of historic or architectural value or interest;

AND WHEREAS notice of intention to so designate the property known as 302 Central Avenue has been duly published and served and no notice of objection to such designation has been received;

The Municipal Council of The Corporation of the City of London enacts as follows:

1. There is designated as being of architectural value or interest, the real property at 302 Central Avenue, more particularly described in Schedule "A" hereto, for the reasons set out in Schedule "B" hereto.

2. The City Clerk is authorized to cause a copy of this by-law to be registered upon the title to the property described in Schedule "A" hereto in the proper Land Registry Office.

3. The City Clerk is authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in the London Free Press, and to enter the description of the aforesaid property, the name and address of its registered owner, and short reasons for its designation in the Register of all properties designated under <u>The</u> <u>Ontario Heritage Act</u>, R.S.O. 1980.

This by-law comes into force on the day it is passed.

The impressive Queen Anne structure at 302 Central Avenue was built in 1896. It contains a variety of exterior architectural features which make it worthy of designation. It is a 2storey yellow brick structure with a cut-stone foundation and features a steep multiple gable slate roof with decorative brackets at the gable ends and a very tall chimney.

Specifically the exterior of this home exhibits a number of interesting characteristics. The porch is particularly noteworthy as it combines a stone base with six Tuscan columns. The front and side gables are decorated with bargeboard that includes a floral cut-out pattern. The brackets consist of patterned woodwork. The front facade features stained glass. There are three arched windows set in the front bay. A Romanesque window is located on the side as is a small circular one with brick surrounds. The home features offset right facade and a door with patterned wood detail and a shaped stained glass transom containing the number 302.
