By-law No. L.S.P.-3343-312

A by-law to repeal By-law No. L.S.P.-3214-349 entitled, "A by-law to designate 179 Clarence Street to be of architectural value."

WHEREAS the Municipal Council enacted By-law No. L.S.P.-3214-349 on September 20, 1993 to designate the property located at 179 Clarence Street to be of architectural value under the provisions of the "Ontario Heritage Act, RSO. 1990, c.0.18";

AND WHEREAS the owners of 179 Clarence Street have submitted an application under section 32 of the Ontario Heritage Act, R.S.O. 1990, c. O.18 to repeal the By-law;

THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

1. By-law No. L.S.P.-3214-349 entitled, "A by-law to designate 179 Clarence Street to be of architectural value" passed by Municipal Council on September 20, 1993, is hereby repealed.

2. This by-law comes into force on the day it is passed.


