

By-law No. L.S.P.-3077-203

A by-law to designate 609 Colborne Street  
to be of architectural value.

WHEREAS pursuant to The Ontario Heritage Act, R.S.O. 1980, c. 337,  
the Council of a municipality may by by-law designate a property including  
buildings and structures thereon to be of historic or architectural value or  
interest;


AND WHEREAS notice of intention to so designate the property known  
as 609 Colborne Street has been duly published and served and no notice of  
objection to such designation has been received;

The Municipal Council of The Corporation of the City of London enacts  
as follows:

1. There is designated as being of architectural value or interest, the  
real property at 609 Colborne Street, more particularly described in Schedule  
"A" hereto, for the reasons set out in Schedule "B" hereto.
2. The City Clerk is authorized to cause a copy of this by-law to be  
registered upon the title to the property described in Schedule "A" hereto in  
the proper Land Registry Office.
3. The City Clerk is authorized to cause a copy of this by-law to be  
served upon the owner of the aforesaid property and upon the Ontario Heritage  
Foundation and to cause notice of this by-law to be published in the London Free  
Press, and to enter the description of the aforesaid property, the name and  
address of its registered owner, and short reasons for its designation in the  
Register of all properties designated under The Ontario Heritage Act, R.S.O.  
1980.
4. This by-law comes into force on the day it is passed.

SCHEDULE "A"

To By-law No. L.S.P.-3077-203

Part of Lot 7, west of Colborne Street, Crown Plan 30, in the City of London and County of Middlesex, designated as part 4 on Reference Plan 33R-7927.

SCHEDULE "B"

To By-law No. L.S.P.-3077-203

The two and a half storey residential building at 609 Colborne Street is worthy of designation for architectural reasons. This white brick Italianate structure was built between 1883 and 1887. It features a low hip roof with projected eaves and large decorated brackets. A small steeply pitched front gable features a small Romanesque window, a drop finial and brackets. The projected left bay and brick voussoirs add variety to the overall appearance of the building. Unusual features include a small opening on the right projected chimney and a variety of window shapes particularly on the right side of the facade. The neo-classical porch is a later addition, and features six Tuscan columns, a decorated pediment and curved wooden railing. The double main doors feature a shaped multiple blind transom and door lights. The three double chimneys are decorated in a reverse step brick pattern.
