Further to our application for funding from the Foundation for the Pakenham Bridge Project I am pleased to advise that the project is now complete and we are very pleased with the results.



BY-LAW NO. 84-36

A BY-LAW TO DESIGNATE A CERTAIN PROPERTY WITHIN THE
MUNICIPALITY TO BE OF HISTORIC OR ARCHITECTURAL VALUE
OR INTEREST

WHEREAS Chapter 337 of the Ontario Heritage Act, R.S.O. 1980 provides that the Council of a Municipality may, by by-law, designate a property within the Municipality to be of historical or architectural value or interest;

AND WHEREAS notice of intention to designate a certain property within the Municipality was published in the Almonte Gazette and Arnprior Chronical October 31, November 7th and November 14, 1984;

AND WHEREAS no objections were received against the designation of the said property as a result of the aforementioned notices;

NOW THEREFORE, the Municipal Council of the Corporation of the County of Lanark ENACTS AS FOLLOWS:

1. The following property be and is hereby designated to be of historic or architectural value or interest;

Description: Pakenham Stone Arch Bridge, Lot 11, Concession XI, Township of Pakenham.

Owner: Corporation of the County of Lanark.


Reason for Designation: The bridge consisting of 5 stone arches was erected in 1901 and is unique in North America. The bridge possesses five masonry arches and was an essential element in the transportation network west of the Mississippi River.

2. This By-Law shall come into force and take effect on the passing thereof.

By-Law read a first and second time this 21st day of November, 1984.

By-Law read a third time short and finally passed this 21st day of November, 1984.
