

**NOTICE OF INTENT TO DESIGNATE**

TAKE NOTICE that the Council of the Town of Lindsay hereby gives Notice of Intent to Designate the building at 51 Cambridge St. N., Lindsay, Ontario, as a building of historical or architectural value or interest under the provisions of the Ontario Heritage Act.

The following features are included in the REASONS FOR DESIGNATION:

- Gothic revival style
- Home of George Wilson (Lindsay Daily Post)
- Multi-storey bay frontispiece
- Baronial tower with ornate brackets and vergeboards
- Decorative masonry lintels and side labels
- Distinctively styled, stained glass windows

The full REASONS FOR DESIGNATION document may be viewed at the Town Hall.

ANY NOTICE OF OBJECTION with reasons, to this designation may be served on the Clerk within thirty (30) days from January 19, 1994, being the date of the first publication of this notice.
