THE CORPORATION OF THE TOWNSHIP OF MARIPOSA

BY-LAW NO. 97-10

BEING A BY-LAW TO DESIGNATE THE PROPERTY KNOWN AS BEECROFT FARM, PART LOT 3, CONCESSION 1, TOWNSHIP OF MARIPOSA, AS BEING OF ARCHITECTURAL/HISTORICAL VALUE AND INTEREST.

WHEREAS, section 29 of the Ontario Heritage Act, 1974 authorizes the Council of a municipality to enact by-law to designate real property, including all building and structures thereon, to be of architectural/historic value/interest; and

AND WHEREAS, the Council of the Corporation of the Township of Mariposa has caused to be served on the owners of the lands and premises at Part Lot 3, Concession 1, Township of Mariposa, and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once.

AND WHEREAS, no notice of objection to the proposed designation has been served on the Clerk of the Municipality;

NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF MARIPOSA ENACTS AS FOLLOWS:

1. There is designated as being of architectural/historical value and interest, Beecroft Farm, Part Lot 3, Concession 1, Township of Mariposa.
2. The Municipal Solicitor is hereby authorized to cause a copy of this By-Law to be registered against the property described in Schedule A hereto in the proper land registry office.
3. The Clerk is hereby authorized to cause a copy of this By-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of passing of this By-law to be published in the same newspaper having general circulation in the Municipality once.
4. This By-law shall come into full force and effect on the date that it is passed.
