





NOTICE OF INTENT TO DESIGNATE

TAKE NOTICE THAT THE Council of the Township of Mariposa hereby gives Notice of Intent to Designate the dwelling at Concession 6 South Part Lot 20, Township of Mariposa, as a dwelling of historical or architectural value or interest under the provisions of the Ontario Heritage Act.

THE REASONS FOR DESIGNATION ARE:

- Queen Anne Style, built on a foundation of random cut fieldstone
 - centre double front door has a transom window
 - either side of entry are large three-sided bays crowned by steep gables
 - the friezeboard of the gables above the bays is decorated with modillion trim and the brackets have volute scrolls
- (Full description of the reasons for designation is available at the Administration Building, Oakwood.)

ANY NOTICE OF OBJECTION with reasons to this designation may be served on the Clerk within thirty (30) days from April 26, 1995, being the date of the first publication of the notice.
