

BY-LAW NUMBER 3079

BEING A BY-LAW TO DESIGNATE THE FORMER POST OFFICE BUILDING, 9 MAIN STREET SOUTH, OF ARCHITECTURAL AND HISTORICAL VALUE.

WHEREAS The Ontario Heritage Act, 1974, authorizes the Council of a municipality to enact by-laws to designate real property, including all the buildings and structures thereon, to be of historic or architectural value or interest; and

WHEREAS the Council of The Corporation of the Town of Kenora being the owner of the lands and premises known as the "Old Post Office" has caused to be served upon the Ontario Heritage Foundation notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in a newspaper having a general circulation in the municipality once for each of three consecutive weeks; and

WHEREAS the reasons for designation are set out in Schedule "B" hereto; and

WHEREAS no notice of objection to the said proposed designation has been served upon the clerk of the municipality;

THEREFORE, The Council of The Corporation of the Town of Kenora enacts as follows:

- l. There is designated as being of architectural value or interest the real property more particularly described in Schedule "A" hereto, known as the "Old Post Office".
- 2. The Municipal Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper land registry office.
- 3. The Clerk is hereby authorized to cause a copy of this by-law to be served upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in a newspaper having general circulation in the Town of Kenora.

SCHEDULE "A"

All and singular that certain parcel or tract of land and premises situate, lying and being in the Town of Kenora, District of Kenora, Province of Ontario, being composed of Lots 179 and 180, Block 2, Plan 3, commonly known as the "Old Post Office", 9 Main Street South.

SCHEDULE "B"

Reasons for the designation of the "Old Post Office Building" at 19 Main Street South:

The structure is most typical and is a prime example of late 19th Century public building design.

The fine brick masonry along with the stone accents around the fenestration is extremely well detailed and is of significant architectural value to the Town of Kenora.

The Clock Tower has been a focal point of the main street activity centre and also the western approach to the town and effectively provides a north closure for the main shopping area in contra-position with the Kenricia Hotel at the south end.
