**NOTICE OF INTENTION TO DESIGNATE**

TAKE NOTICE that the Council of the Corporation of the Township of Ramsay intends to designate the property, including lands and buildings, at the following municipal address as property of architectural and historical value or interest under Part IV of the Ontario Heritage Act, R.S.O. 1990, Chapter 0.18.

**REASONS FOR DESIGNATION:**

This white frame house, situated on a prominent rise of land overlooking the Mississippi River, on part of the original 200 acre parcel of land patented originally to the Canada Company in 1829, and subsequently sold to James Wilson in 1836, was built by Wilson's son William Wilson sometime around 1840.

William Wilson, born in Lanarkshire, Scotland, came to Upper Canada with his parents, in 1828. He was a farmer and an accomplished cabinet-maker and architect and served as a member of the first Council of the Township of Ramsay, 1850-52.

The house to be designated, is of typical Ontario one and one-half story frame construction with centre gable, decorated with the original bargeboard trim and clad with clapboard. A kitchen wing, somewhat unusual at the time, is placed at the west side of the building rather than behind.

A remarkable grouping of five black locust trees, deemed by experts to be close to 150 yrs. old and therefore probably planted by William Wilson, line the front of the property and form a significant setting to this heritage property.

A tombstone, marking the grave of a son Albert, who died in 1866, was formerly located under an apple tree in the back yard and is now an artifact of the North Lanark Museum.
