CORPORATION OF THE TOWNSHIP OF RAMSAY

BY - Law # 1662A

A BY -LAW to designate the premises known municiplaly as the "Former S.S. # 9 Schoolhouse" situated on part of the East Half of Lot 16, Concession 7, Township of Ramsay, more particularly described in instrument # 30690, as being of Architectural and Historical value and interest.

WHEREAS The Ontario Heritage Foundation Act, R S O 1980, Chapter 337, authorizes the council of a municipality to enact by-laws to designate real property including all buildings and structures thereon to be of architectural value or interest: and

WHEREAS the council of the Corporation of the Township of Ramsay has caused to be served on the owners of the premises known as the "Former S.S. # 9 Schoolhouse" situated on part of the East Half of Lot 16, Concession 7, Township of Ramsay, more particularly described in instrument # 30690, and upon The Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and have caused such notice of intention to so designate, to be published in the same newspaper having general circulation in the municipality, once a week forthree consecutive weeks: and

WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the Municipality,

THEREFORE the Council of the Corporation of the Township of Ramsay enacts as follows:

- 1. There is designated as being of architectural and historical value or interest, the real property known as the "Former S.S. # 9 Schoolhouse" situated on the property known municipaly as part of the East Half of Lot 16, Concession 7, Township of Ramsay, more particularly described in instrument # 30690.
- 2. The Municipal Solicitor is hereby authorized to cause a copy of this By-Law to be registered against the property described, in the proper Land Registry Office.
- 3. The Clerk is hereby authorized to cause a copy of this By-Law to be served on The Ontario Heritage Foundation and to cause notice of the passing of this By-Law to be published in the same newspaper having general circulation in the municipality, once a week for three consecutive weeks.

Read a first, second and third time and passed, this 14th day of August, 1984.
