## NOTICE OF INTENTION TO DESIGNATE

Take notice that the Council of The Corporation of the Town of Huntsville on the 23rd day of September, 1985 decided to designate the lands and buildings known municipally as:

HUNTSVILLE TOWN HALL - 37 Main Street, East
 HARMONY HALL - 27 Minerva Street

as a property of architectural and historical value or interest under the Ontario Heritage Act, R.S.O. 1980, Chapter 337.

## SHORT STATEMENT OF REASONS FOR THE PROPOSED DESIGNATION

1. Huntsville Town Hall - The Huntsville Town Hall, with its unique eight (8) sided, wooden clock tower, is a landmark building within the Town. The Town Hall is prominently placed above and back from the Main Street to emphasize its importance. The height and mass of the red brick building fit into the scale of the downtown area.

The symmetry of the elevations, the large palladian window above the main entrance, the decorative brick work and the horizontal stone courses and connices distinguish the Town Hall as one of the few Classical Revival style administrative buildings in the area. The building, designed by architects, Ellis and Belfry of Toronto, was built in 1926 on land purchased from the Methodist Church. It was originally used as the Post Office, as well as for Municipal Offices, and to this day is still a multi-use building.

Harmony Hall - This fine residence with its classical references is unique in the Huntsville area, where many of the large turn-of-the-century houses were built in the Victorian Style.

The strong horizontal lines, emphasized by the bevel wood siding, the porch with wooden columns that have ionic capitals and bases, plus the enclosed porches with decorative small panes of glass are some of the architectural elements that distinguish this large rambling home, which is situated on a generous lot overlooking Hunter's Bay. The house was built in 1905. In 1918, it was purchased by C.O. Shaw of the Anglo-Canadian Leather Co. of Huntsville, for the use of Herbert L. Clarke, the world famous cornet player and band director. Mr. Clarke led the Anglo-Canadian Concert Band to great musical acclaim throughout North America, when he lived in this house from 1918-1923.

Notice of the Objection to the designation may be served on the Clerk within thirty days of the 2nd of October, 1985.
