BY-LAW NUMBER 2001-23

**Being a By-law to Designate the Property known
Municipally as "St. Andrew's Presbyterian Church",
located at 7 High Street, Part Lot 19, Part Lot 20,
Plan 1, Huntsville Ward, Town of Huntsville,
to be of Architectural and Historical Value or Interest.**

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1990, Chapter O.18 authorizes the Council of a Municipality to pass by-laws to designate a property within the municipality to be of historic or architectural value or interest;

AND WHEREAS the Council of the Corporation of the Town of Huntsville has caused to be served on the owners of the lands and premises known as "St. Andrew's Presbyterian Church", located at 7 High Street, Part Lot 19, Part Lot 20, Plan 1, Huntsville Ward, Town of Huntsville, Roll No. 010-010-03400.0000 and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality;


AND WHEREAS no notice of objection to the proposed designated has been served on the Clerk of the Municipality;

NOW THEREFORE The Council of the Corporation of the Town of Huntsville enacts as follows:


1. This is designated as being of architectural and historical value or interest the real property know as "St. Andrew's Presbyterian Church", located at 7 High Street, Part Lot 29, Part Lot 20, Plan 1, Huntsville Ward, Town of Huntsville, more particularly described as Schedule "A" attached hereto.
2. The Municipal Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" attached hereto, in the proper land registry office.
3. The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspaper having general circulation in the municipality.







SCHEDULE "A"

REASONS FOR DESIGNATION

ST. ANDREW'S PRESBYTERIAN CHURCH

7 High Street
Part Lot 19, Part Lot 20
Plan 1, Huntsville Ward
Town of Huntsville

On October 17, 1869, the first regular service in Huntsville was held in Captain George Hunt's cabin with the Rev. R.N. Hill. In November of the same year work started on preparing the lot donated by Captain Hunt, bounded by Mill Street, Church Street, Main Street and Fairy Avenue. A church was built on this property during the time of Rev. Thirde and completed during Rev. James Sieveright's ministry. This church burned down about the year 1895/96. The congregation met in Snyder's hall for almost two years while a replacement church was being built on the corner of High Street and West Street. The new handsome church was opened on April 17, 1899, and has served the congregation well over the past century.

This building is being designated for both architectural and historical reasons. Huntsville Heritage intends to designate under the Ontario Heritage Act, the east and north facades of St. Andrew's Presbyterian Church, as well as the original section of the western exterior. This handsome red brick church marks the corner of High Street and West Street with the placement of a robust tower. The prominent American Architect H. H. Richardson, who in turn was inspired by Romanesque architecture in Europe, inspired the style of the church. This style can be noted in the chunky weight of the building volume, the high stone foundation, the heavy corbelled eave at the tower, the brick arches and brick patterns, round headed windows and four pinnacles surrounding an eight sided spire.

The bell for the church was donated by D.M. Grant in 1898. Meneeley & Co. of Troy, New York manufactured this bell.

The church is a good example of a well-maintained building that has respected and preserved the original architecture.


