

## NOTICE OF INTENTION TO REPEAL A BY-LAW

TAKE NOTICE that the Council of the Corporation of the Town of Newmarket intends to remove the designation from the buildings including lands on the premises located on the west side of Yonge Street at 16950 Yonge Street, in the Town of Newmarket in the Province of Ontario by repealing By-law 2000-127.

By-law 1991-127 is being repealed because the building located at 16950 Yonge Street was relocated to 17100 Yonge Street. The property located at 16950 Yonge Street is no longer deemed to be of architectural or historical value.

Notice of Objection to the repealing by-law may be served on the Clerk within thirty days of the first date of this publication.
