A BY-LAW TO DESIGNATE PROPERTIES AS BEING OF ARCHITECTURAL AND/OR HISTORICAL VALUE AND INTEREST.

WHEREAS section 29 of The Ontario Heritage Act, 1974 authorizes the council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historical value or interest; and

WHEREAS the council of the Corporation of the Village of Merrickville has caused to be served on the owners of the lands and premises of lot 151 lot 5 Range 2 notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks; and

WHEREAS the reasons for designation are set out in Schedules A,B, hereto.

WHEREAS no notice of objection to the proposed designation has been served on the clerk of the municipality.

THEREFORE the council of the Corporation of the Village of Merrickville enacts as follows:

- 1) There is designated as being of architectural and/or historical value or interest the properties shown on Schedules A,B, of this By-Law.
- 2) The municipal solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedules A to B in the proper land registry office.
- 3) The clerk is hereby authorized to cause a copy of this by-law to be served on the owners of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.

Read a first, second and third time and passed this 14th day of November 1983.

Knox Presbyterian Church lot 151 St. Lawrence St.

Knox Presbyterian Church, built in 1861 is recommended for designation for architectural and historical reasons. It is the oldest original church building in the Village. Architecturally it is of interest as it appears to be modelled after earlier churches built of wood. It is built of red brick with a tower of yellow brick, a later addition. The symmetrical facade is centered by the square tower. Windows in each wall, are double arched with pointed Gothic arches. Tower corners have wood finials.

lot 5 St. Lawrence Street East.

This 2½ storey shop built c. 1860 is significant as part of the streetscape of the main business section of the Village. The main building is of rubble stone construction with flat arch stone lintels in a three-bay side hall plan. The upper storey, probably a later addition, is built into the roof.
