BY-LAW NO. 81-51

A BY-LAW TO DESIGNATE 285 QUEEN STREET AS A PROPERTY OF

ARCHITECTURAL VALUE OR INTEREST UNDER THE PROVISIONS OF THE

ONTARIO HERITAGE ACT, 1974

PASSED: January 19, 1981

WHEREAS Section 29 of The Ontario Heritage Act, 1974
authorizes the Council of a municipality to enact by-laws to
designate real property, including all buildings and structures
thereon, to be of architectural or historic value or interest;

AND WHEREAS notice of intention to designate 285 Queen Street was served on the owner of 285 Queen Street and on The Ontario Heritage Foundation on the 12th day of November, 1980 and was published in the Whig-Standard on November 12th, 19th and 26th, 1980;

AND WHEREAS no notices of objection to the proposed designation have been served on the Clerk of the City of Kingston;

THEREFORE the Council of The Corporation of the City of Kingston enacts as follows:

- 1. There is designated as being of architectural value or interest the real property known as 285 Queen Street in the City of Kingston, as more particularly described in the Schedule "A" attached hereto.
- 2. The City Solicitor is hereby authorized to cause a copy of this by-law and the reasons for designation to be registered against the property described in Schedule "A" hereto in the Land Registry Office at Kingston, Ontario.
- 3. The City Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the property

described in Schedule "A" hereto and on The Ontario Heritage Foundation, and to cause notice of the passing of this by-law to be published in the Whig-Standard once for each of three consecutive weeks.

This by-law shall come into force and take effect on its passing.

285 Queen Street

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the City of Kingston, in the County of Frontenac, in the Province of Ontario, and being composed of Lot 9, Plan 1642, and more particularly described in Instrument No. 115822.

REASONS FOR DESIGNATION OF 285 QUEEN STREET, APPROVED AT THE MEETING OF CITY COUNCIL HELD ON JANUARY 12, 1981 (Clause 2, Report No. 11), AS PROPERTY OF ARCHITECTURAL VALUE OR INTEREST

This small Church, built about 1837 for the Catholic Apostolic Church, is distinguished by its fine Gothic arched openings - windows, doors and blind arches. Slight projections divide the facade into three bays.
