Designation of 44 Princess Street Under the *Ontario Heritage Act*

Dear Sirs:

Upon review of our files, we found that Notice of the Passing of a By-Law was not served upon the owner or the Ontario Heritage Foundation as required. BY-LAW NO. 82-112(A)

A BY-LAW TO DESIGNATE 44 PRINCESS STREET AS BEING OF ARCHITEC-TURAL AND HISTORICAL VALUE OR INTEREST, PURSUANT TO THE PROVISIONS OF THE ONTARIO HERITAGE ACT

PASSED: June 14, 1982

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1980, Chapter 337 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest;

AND WHEREAS a notice of intention to designate 44
Princess Street was served on the owner on the 15th day of
April, 1982, and was published in the Whig Standard on April
15, 1982, April 22, 1982 and on April 29, 1982;

AND WHEREAS no notices of objection to the proposed designation have been served on the Clerk of the City of Kingston;

THEREFORE the Council of The Corporation of the City of Kingston enacts as follows:

- There is designated as being of architectural and historical value or interest the real property known as
 Princess Street, in the City of Kingston, as more particularly described in Schedule "A" attached hereto.
- 2. The City Solicitor is hereby authorized to cause a copy of this by-law and the reasons for designation to be registered against the land described in Schedule "A" hereto in the Registry Office at Kingston, Ontario.
- 3. The City Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the land described in Schedule "A" hereto and on The Ontario Heritage Foundation, and to cause notice of the passing of this by-law to be published

in the Whig Standard once for each of three consecutive weeks.

4. This by-law shall come into force and take effect on its passing.

REASONS FOR DESIGNATION OF 44 PRINCESS STREET
APPROVED AT THE MEETING OF CITY COUNCIL
HELD ON JUNE 7, 1982 (CLAUSE 1B, REPORT NO. 70)
AS BEING OF ARCHITECTURAL AND HISTORICAL VALUE OR
INTEREST

Built in 1833 to designs by Thomas Rogers, this building was occupied by the Commercial Bank until 1853. Later, it was occupied by the Royal College of Physicians and Surgeons of Kingston. Later additions replaced the front portico but have not obscured the second storey blind arches, the fine proportions of the side walls and of the rear.
