BY-LAW NO. 87-335

A BY-LAW TO DESIGNATE 462 KING STREET WEST OF HISTORIC AND/OR ARCHITECTURAL VALUE OR INTEREST PURSUANT TO THE PROVISIONS OF THE ONTARIO HERITAGE ACT

PASSED: October 20, 1987

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1080, Chapter 337 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest;

AND WHEREAS notice of intention to designate 462 King Street West, in the City of Kingston, was served on the owners of the property and on the Ontario Heritage Foundation and was published in the Whig-Standard;

AND WHEREAS a notice of objection to the proposed designation was served on the Clerk of the City of Kingston;

AND WHEREAS a Conservation Review Board hearing was held on September 23, 1987, and the Decision has now been received;

AND WHEREAS the Local Architectural Conservation Advisory Committee has recommended that this property be designted pursuant to the provisions of the Ontario Heritage Act;

NOW THEREFORE the Council of The Corporation of the City of Kingston enacts as follows:

- 462 King Street West in the City of Kingston is 1. hereby designated as being of architectural value and interest pursuant to Section 29 of the Ontario Heritage Act.
- 2. The subject property is more particularly described in Schedule "A" attached hereto.

- 5. This By-Law shall come into force and take effect on its passing.

REASONS FOR DESIGNATION OF 462 KING STREET WEST APPROVED AT THE MEETING OF CITY COUNCIL HELD ON OCTOBER 6, 1987 (CLAUSE 16, REPORT NO. 112)
AS BEING OF ARCHITECTURAL VALUE AND INTEREST

Architect David Shennan designed this large stone dwelling for Thomas McGinnis. Set in extensive grounds fronted by a handsome iron fence, the series of high parapetted gables and two massive stone chimneys give special distinction to this 1924 house.
