NOTICE OF INTENTION TO DESIGNATE

1. The Council of The Corporation of the City of Kingston intends to pass a by-law to designate the following property to be of historic and architectural value or interest, pursuant to Section 29 of the <u>Ontario</u> <u>Heritage Act</u>:

50 Earl Street

Part of Lot 134, and Part of Lot 147, Original Survey, City of Kingston, County of Frontenac

Reasons for Designation:

This two storey red brick house, built in 1875, provides part of the east gable wall of The Winston. The round headed entrance with fanlight and six panelled door and above it a second storey window, are set in a slight projection. The first bay has six over six shuttered windows in both storeys.

- 2. Any person interested may, within thirty (30) days after the date of this notice, send by registered mail or deliver to the Clerk of The Corporation of the City of Kingston notice of his or her objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts.
- 3. Where a notice of objection has been received, the Council of The Corporation of the City of Kingston shall refer the matter to the Conservation Review Board for a hearing and report.
