NOTICE OF INTENTION TO REPEAL HERITAGE DESIGNATION BYLAW

TAKE NOTICE THAT upon the request of the owner of the property at 15278 Yonge Street, Aurora, and due to the deteriorated condition of the Blacksmith's Tree, as confirmed in a written arborist's report, the Council of The Corporation of the Town of Aurora intends to repeal, pursuant to subsection 32(2) of the *Ontario Heritage Act*, R.S.O. 1990, c. O.18, By-law 5053-08.R being a by-law to designate the property at 15278 Yonge Street (the Blacksmith's Tree) as being of cultural heritage value or interest.
