TAKE NOTICE that the Council of the Corporation of the Township of Muskoka Lakes intends to repeal By-law 84-109 designating the property, including lands and buildings, at the following municipal address as a property of historical value or interest under The Ontario Heritage Act, R.S.O. 1980 Chapter 337.

- (a) Old Bala Hydro Plant, Concession A, Lot 14, Plan 26, Part of Lot 275, River Street, in the Geographic Town of Bala, now in the Township of Muskoka Lakes in the District Municipality of Muskoka, Province of Ontario, as it is the interest of Council to cause the Old Bala Hydro Plant to be re-established as an electric power producing facility or failing this to be removed from the property.

Notice of objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the Corporation of the Township of Muskoka Lakes in the District Municipality of Muskoka before the 7th day of December 1986.
