The Corporation of Norfolk County By-Law 2017-15

Being a By-Law to Amend By-Law 100-92 of the former City of Nanticoke, to Designate the Property located on Part Lot 13, Concession 11, Geographic Township of Townsend, designated as Part 2 on Reference Plan 37R-2373, Norfolk County, PIN 50272-0160 (LT), as a Property of Historical and Architectural Value. (Wallace/Armstrong Residence)

WHEREAS the former City of Nanticoke By-Law 100-92 was passed on December 8, 1992 and registered in the Registry Office of the Land Registry Division of Norfolk (No. 37) on December 17, 1992 as Instrument No. NR492977, designating the Wallace/Armstrong property under the Ontario Heritage Act;

AND WHEREAS the owner of the Wallace/Armstrong property has given consent to a recommendation made by the Manager of Heritage and Culture and the Norfolk Heritage Committee to amend the property's heritage attributes by de-designating seventeen (17) original single pane, double hung wood framed windows that are in very poor condition and require replacement and designating only two existing feature windows located along the west elevation and north elevation of the Wallace/Armstrong residence:

AND WHEREAS written notice of the proposed Heritage Designation Amendment has been given to the property owner, as required under the Ontario Heritage Act, R.S.O., C. O.18, section 30.1(2) to (10), and no notice of objection has been received by the Clerk within 30 days of receiving the said notice;

- That the Clerk is hereby authorized and instructed to register a copy of this By-Law against the aforesaid property in the Registry Office of the Land Registry Division of Norfolk;

- 3. That the Clerk, or his/her designate, is hereby authorized to amend the parcel designation noted in this By-Law, if necessary, upon registration of this By-Law
- 4. That the effective date of this By-Law shall be the date of passage thereof.
